In particular, resolution No PQ-2909 dated April 20,2020 "Measures to further develop the system of higher education" serves to radically improve the system of higher education, to reconsider the content of training based on the priorities of socio-economic development of the country, to create the necessary conditions for training specialists with higher education in accordance with international standards, to ensure active participation in the comprehensive reforms in the country. In order to consistently implement the tasks set out in the Action Strategy for the five priority directions of development of the Republic of Uzbekistan in 2017-2021 and for radical improvement of the content of training highly qualified competitive personnel in the higher education system of the republic based on the prospects of socio-economic development of the country, the needs of society, achievements modern of science, engineering and technology by further expanding the participation of industries and sectors of the economy in improving the quality of higher education6 the Resolution of the President of the Republic of Uzbekistan dated June 5, 2018, "Additional measures to improve the quality of education in higher education institutions and ensure their active participation in the ongoing comprehensive reforms in the country" was adopted.

### Materials and methods

Resolution of the President of the Republic of Uzbekistan dated July 27, 2017 "Measures to further expand the participation of industries and sectors of the economy in improving the quality of training of higher education" focuses to improve the process of training highly qualified personnel with spiritual and moral qualities, independent thinking to a qualitatively new level, to modernize higher education, to develop the social sphere and

the economy based on advanced educational technologies.

The Decree of the President of the Republic of Uzbekistan dated October 8, 2019 "Approval of the Concept of development of higher education in the Republic of Uzbekistan until 2030" plays great role for radical improvement higher education system, for creation the necessary conditions for the training of highly qualified specialists at the level of international standards.

In order to further reform and develop the education system in Uzbekistan, 2020 was declared as "Year of Science, Enlightenment and Digital Economy" and The Decree of the President of Uzbekistan "State Program for the Year of Science, Enlightenment and Digital Economy" was adopted in March 2, 2020. This State Program consists of 299 couplet and projects with the total amount of 18.2 trillion soums and 10.3 billion USD were approved within this program. According to this program in 2020/2021 academic year:

- the parameters of admission to higher education institutions on the basis of state grants will be gradually doubled (from 22,696 to 45,392);
- students will be given the opportunity to pay for tuition in equal shares at least 4 times during the academic year.

Also, on September 23, 2020, the President of the Republic of Uzbekistan signed the Law "Education". After, the Laws "On Education" dated August 29, 1997 and "National Program of Personnel Training" became invalid.

It is known that education is an important condition for creating prosperity, introducing new technologies and improving living conditions. Today, one of the challenges in higher education is that, do Higher education graduators (Table 1) can find their place in a constantly changing labor market. Has he acquired the knowledge and skills during his higher education that enable him to fully participate in the evolving innovative economy, improve his life and contribute to the development of society? The social significance

of higher education lies in answering these questions.

If we focus on the experience of developed countries, their higher education system and its development will be determined by the priorities of the national strategy. In the past, taking into account the needs of the real sector of the economy and social sphere, new universities and branches of foreign universities were opened in the regions. Training of required personnel at the bachelor's and master's degree has been established. The concept of development of the higher education system of the Republic of Uzbekistan until 2030 has been approved. This identifies the following priorities for reforming the higher education system:

- to raise to a qualitatively new level the training of highly qualified personnel with modern knowledge and high spiritual-moral qualities and independent thinking;
- strategic tasks in the modernization of higher education, development of the social sphere and economic spheres based on high education technologies.

These tasks are aimed at overcoming existing problems, organizing the industry at the level of modern requirements. In particular, it is planned to develop public-private partnerships in the field of higher education on the basis of the establishment of state and non-state higher education institutions in the regions by 2030 - the coverage of higher education has exceeded 50%.

The concept defines strategic goals, priorities, medium and long-term stages of development in the Republic of Uzbekistan. This

document serves as a basis for the development of programs and comprehensive measures in this area.

As a result of the practical implementation of the planned work in the process of reforming the education system, a solid, legal, organizational, material and technical base has been formed. It helps to update the content of teaching the younger generation. The system of upbringing and educating a harmoniously developed generation in the country has become one of the priorities of state policy.

Parents 'attitudes also changed, as they began to pay more attention to teaching children from an early age. This increases the need to expand the coverage of children with preschool education. As a result, the number of preschool institutions is increasing. The population's need for education, modern attitudes also serve as a basis for increasing the number of non-governmental schools and universities.

Based on the above, the following conclusions can be drawn: in the current situation, the competitiveness of countries depends primarily on the level of education and science. The current development of the economy and society places more demands than ever on the quality of vocational training.

Requirements for the employee's suitability for a particular activity are regularly changed and strengthened.
